Support the Joint Letter “Urgent Call to Action: A Place for Brain Health at the Top of EU Policy Agendas”

With the 2024 European Elections now behind us, EBC, its member organisations, and the wider brain community are seeking support for increased prioritisation of brain health on EU health and research agendas.

As part of the No Health Without Brain Health campaign, EBC prepared a Joint Letter to newly elected Members of European Parliament, titled "Urgent Call to Action: A Place for Brain Health at the Top of EU Policy Agendas," calling for the formation of an Intergroup on Brain Health and Research within the new mandate and the continued creation of national brain plans and a comprehensive European brain strategy. More than 70 organisations are now supporting our Call to Action echoing key policy asks from the European Brain community!

On 28th of June, the International Phenylketonuria Day, EBC has released Study Insights on "The Value of Education: Digital Care Pathways for Rare Brain Diseases research project – The Case of Phenylketonuria".

The opportunities offered by data and digital health are multiplying. While barriers remain to unlocking their full potential, we are at an unprecedented moment of change. The European Health Data Space and the AI Act hold the promise of shaping a digital ecosystem that can accelerate the shift towards patient-centred, outcomes-focused, and sustainable healthcare in Europe, and improve patient safety and reduce avoidable harm. Patient care is undergoing a significant transformation, and three key factors – data, patient education and inclusivity – are at the forefront of this change. To gain a deeper understanding of these trends, we examined both patient and provider views. These insights offer a glimpse into the future of patient care.

brain health. The speakers and the participants shared their perspectives on the roles and contributions that international organisations can bring to the future European Partnership for Brain Health.



EBC was delighted to participate in the 10th European Academy of Neurology Congress (EAN) which took place under the overarching theme "Neuromodulation: advances & opportunities in neurological diseases" from 29 June until 2 of July in Helsinki (Finland). This year's Congress has reached record-breaking attendance with more than 7,000 onsite attendees, 2,000 virtual participants and a record number of 2,777 submitted




Support EFNA's Call to Action for Rare Neurology!
