The Coordination & Support Action (CSA) BrainHealth has launched a Public Consultation on the Strategic Research and Innovation Agenda (SRIA) for the upcoming European

Partnership for Brain Health (EP BrainHealth). This initiative aims to address the challenges of brain disorders by promoting brain health and enhancing the well-being of individuals with neurological and mental health conditions. The consultation, open from July 17 to August 14, 2024, seeks input from stakeholders and the public to refine the SRIA. The EP BrainHealth builds on previous European initiatives and aims for collaborative solutions in brain health research, prevention, diagnosis, and therapy. Participants can review the SRIA document and provide feedback through an online survey.


Last chance to fill out the Rethinking Schizophrenia survey!

Intersectoral Global Action Plan on Epilepsy and Other Neurological Disorders: Implementation Toolkit

World Health Organization has published a new implementation toolkit to the Intersectoral global action plan on epilepsy and other neurological disorders (IGAP), outlining specific

actions and resources for countries to improve services for people with neurological disorders in preparation for meeting IGAP's targets for 2031.

The implementation toolkit is the go-to resource for those involved in shaping neurology policies and services. It is primarily intended for use by policy-makers at national and subnational levels as well as programme managers and service planners across various sectors such as health, social services, education, environment, finance, employment, justice and housing. The toolkit is designed to correspond to the IGAP strategic objectives, focusing on 5 strategic areas.

Listing specific steps as well as 90 tools and resources, the toolkit allows plans for IGAP implementation to be customised according to the context of the country, recognising the advances in neurological disorder care that may have already been made in that setting.

EBC participated in the International Association for the Study of Pain 2024 World Congress on Pain, with three poster presentations featuring the Value Of Treatment case study on Chronic Pain disorders on 6th of August in Amsterdam.

The Value Of Treatment project aims to examine health gains and socio-economic impacts resulting from optimised healthcare interventions in comparison with current care or inadequate treatment and converge data evidence to policy recommendations on how to improve the care pathways.


EBC Joins the Call to Action on the Implementation of the EU Joint Clinical Assessment for ATMPs
